3. Old Business

- a. Rehab Property Update: Ed Jennings did an inspection of both properties this week. Pictures of Cattaraugus were shown and Ed explained what was being seen.
- b. Contract extension through October 16th has been sent to Western Door for signature.
- c. Western Door is now very close to having both houses finished.

16 South Main Franklinville:

- They have replaced the front door, but the front window still needs to be installed.
- One of the gutters needs to be repaired.
- The gas insert in the fireplace needs to be finished.
- The water damage in the bathroom needs to be repaired.
- The property is listed at \$219,000, it has been shown numerous times.
- The realtor wants to drop the price to \$209,000. Motion to lower the price by Dan Martonis with a second by Crystal Abers. Approved.

209 S Main in Cattaraugus:

• Cabinets are being put up in the kitchen. Decking needs to be put on the second story porch floor and a screen needs to be put up on that porch where the wires come into the house to keep anyone from touching them.

- The railings on the second floor porch were torn off and replaced with taller railings to match the first floor porch railing.
- They framed the windows with aluminum.
- The railings have been added to the interior stairways.
- They are going to add insulation to the attic space.
- The ceiling needs to be replaced on the porch and the porch floor needs to be scraped and painted.
- Some trim on the back of the house needs to be replaced.
- Kate has shown the house to a low/mod income family who qualifies to purchase the property. She is very interested and is currently looking for a mortgage.
- There was an offer from the woman for \$79,000, the Board did not accept it.
- She made a counter offer of \$85,000. The Board voted via email to accept the bid.
- The ambulance service next door contacted Dan Martonis, they want to sell a small parcel of land that is behind the house to the land bank or the new owner of the property. They will be told that is something to ask the new owner about after the home is sold.
