#### 4. New Business:

- 2021 County Auction- validity of the foreclosure filing may be challenged because of the Executive Order from the Governor. They are a bit behind so they are looking at June for the Auction right now.
- Matt Keller will bring the auction book to Kate so that she can get an idea of what may fit the Land Bank criteria.

P-Card Discussion- Rick Helmich reported that he was involved with a NACHO call concerning a P-Card. The card would need to be owned by Cattaraugus County Treasurer and they would assign a card to the Land Bank.

- They have a purchase card that there is a rebate currently, however the Land Bank is not the one buying the materials, it is through the contractors. So this would slow down the process if the Land Bank needs to purchase the materials for the contractor.
- Mr. Helmich discussed that it could be written in the specifications that the contractor has to purchase the materials from certain places where the Land Bank can pay with the card.
- Matt Keller discussed that the amount that they get back on these rebates is very small for the (.008). He believes that we will be spending more chasing the rebate.
- Kate O'Stricker voiced a concern that the Land Bank is a contracted service for the county. Will we be opening up an avenue for other contracted services to ask the county for the same benefit.
- Mr. Helmich believes that the rebate may be better than that of the card the treasurer's office currently has.

#### OPEN DISCUSSION:

- Discussed the options that the Land Bank has for funding once Enterprise funds are completed
- Housing Market after the pandemic with the homeowners and landlords not making payments
- Houses is selling very quickly at this time.
- We have a need for more contractors to bid on our rehabs. Matt Keller mentioned that the insurance that we require is our biggest barrier.

## 5. Action Items

- Car in Olean on 12<sup>th</sup> Street demo. (Buick LeSaber 2005 or 2007) We may need to go through the abandoned car form from the DMV. With the abandoned car we will never get a title.
- Kate will send out the bid for Olean Portville Road for vote from Board.
- Rehabilitation Bids will go out to the Board
- Talk to Dr. Watkins about the Lead Testing
