b. Rehab Property Update:

Rehabs 2019:

**215 South Barry Olean**- Western Door awarded (\$90,240). Contract executed. Work is well on the way. Ed Jennings has made several inspection stops and has supplied CCLBC with many inspection reports. Ed discussed the last inspection, and showed pictures of the progress.

- Noted that the staircase spindles were sent to be milled. They came back as a perfect match.
- There were no subcontractors on the site
- A change from the scope, the air conditioning unit and heating unit will be replaces since it is more cost effective than repairing both of them.
- Chimney Stack has been completed
- Plumbing is all done
- No microwave installed
- Peaked Garage Roof was installed.
- There were a few punch list items to resolve, the furnace and air conditioner

138 North 17<sup>th</sup> Olean- Property has been gutted, rewired, plumbed, new windows, new heat ducts, insulation is beginning (R49 factor). Drywall will begin in a week and a company will be hired to refinish the original harwood floors. Garage will be addressed after the inside of house is complete.
209 South Main Cattaraugus- Western Door awarded (\$107,035). Contract executed. Should start this week.
