# a. Rehab Property Updates

# i. 701 North Union, Olean

- 1. Ed has been out twice, stated that the home has been gutted and now getting new electric including 100-amp panels to each apartment with new service.
- New windows, with new framing by Amish and old plumbing will most likely need replaced if pipes are galvanized/cast iron but haven't started yet.
- Exterior looking well roof was redone and drainage is working well. Insulation still to be added. Still has a few tree limbs on property but most of garbage and debris has been taken out.
- ii. Ryan stated that the Health Department is starting a new initiative and would like a report of how many homes are still using galvanized/leaded pipes in the City of Olean, this is currently being done, trying to contact individuals to get report finished.
